

 - Text (e-mail) and web (LIR Portal) versions


- Completed updates

Systems Upgrades

- PABX replaced by VoIP solution
 - One-to-one replacement completed
 - Preparing SIP server integration
- Network Upgrades
 - Layer 2 equipment exchanged
- Ticketing system replacement
 - Prototyping phase
 - Integration planning
 - Re-evaluating requirements

- Recognition of (also) our Governance mechanisms.
- But...
 - Everybody is happy with the outcome...
 - Some issues never die...
 - Very hard to get equal standing for "Internet Community" equal to other stakeholders.
 - Enhanced Cooperation?





On the Way to Greece - WGIG Redux?

- WSIS called for Internet Governance Forum (IGF) to
 - Affect international public policy
 - Advance development
 - Create discussion forum for all stakeholders on equal footing
 - Not to affect operations, or take over issues from other fora
- To meet 28 October 2 November, Athens
 - Chaired by Nitin Desai (chair WGIG)
 - Geneva Secretariat (lead by Markus Kummer)
- Program Committee -> Advisory Group
 - 20/10/10 composition from governments, private sector, civil society
 - To be appointed by UNSG
- Not to be governed by UN procedures

- Roundtable for Governments & Regulators
 - Third Roundtable meeting

 - Plans for meetings in Russia & Gulf Region





Summary

- Service focus:
 Make use of improved systems as they become available
- Engineering focus: Mostly Internal
- Communications and Coordination focus: "Enhanced Cooperation": Outreach, IGF

What

- Easily verifiable assertions
 - Identity: "RIPE NCC knows this party."
 - Resource Allocation: "RIPE NCC has allocated this resource to this party."
 - Based on PKI
 - for technicalities see other presentations





Why

- Improve stability of the Internet
- Assertion validation procedure
 - Identity
 - Resource allocation
- Strengthen relationship between RIPE NCC & its members
- High(er) quality of allocation data
- Helpful to ensure routing security
 - Check route injection authority
 - Automate trust relationship





How / Open Issues

- Is resource certification mandatory?
- Identity certification
 - Acceptance of third party certificates
- Cost of certification
 - Members
 - Non-members
- Will certificates be used by third parties?
 - I don't know...
- Expiration handling
- Revocation
- Inter-RIR coordination
 - There Must Be Compatibility!
