- RIPE NCC a founder of Internet Technical Advisory Committee (ITAC) in 2008
  - Recognising OECD as an inter-governmental org integrating multi-stakeholder methods
- Current projects
  - IPv6 study, "The Internet in Transition: The State of the Transition to IPv6", authored by Geoff Huston (APNIC)
  - RIPE NCC and several other ITAC members funding OECD study on "International Cables, Gateways, Backhaul and IXPs"



#### Internet Governance Forum

- NRO submission to Open Consultation
  - Renewed financial commitment (USD 100k); importance of broader contributor base
