# Executive Board Meeting Decisions



- Approved amendments to the following:
  - The RIPE NCC LIR Account agreement (submit electronically)
  - RIPE NCC Services for Legacy Internet Resources (submit electronically)
  - RIPEstat Service Terms and Conditions
- Reviewed the RIPE NCC Treasury Statute, according to the agreed yearly review cycle, and resolved that the Treasury Statute remains unchanged.

# Executive Board Meeting Decisions



- Approved the publication of the Draft Activity Plan and Budget 2020
- Approved proposed amendments to the Articles of Association (Linda will present on this later)
- Approved amendments to the RIPE NCC procedural document “Due Diligence for the Quality of the RIPE NCC Registration Data”
- Accepted the role of appointing the ‘NomCom chair’ for ‘The RIPE Chair Selection Process’

# NomCom Appointment



- This is for the RIPE Chair Selection Process and the RIPE Nomination Committee
- The Executive Board is tasked with appointing the Nominations Committee (NomCom) chair
- It will confirm the selections made by the NomCom
- Daniel Karrenberg is appointed to be the NomCom chair
- These activities will be carried out as per the procedures in ripe-727 (<https://www.ripe.net/publications/docs/ripe-727>) and ripe-728 (<https://www.ripe.net/publications/docs/ripe-728>)

# Proposed Articles of Association Amendments



- The Board is proposing one change to the Articles of Association to be voted on today
  - Article 18.4 of the Articles of Association provides for Instant Runoff Voting only for the election of persons
  - The proposed amendment introduces Instant Runoff Voting for other resolutions

# Clearing House Reserve



- Special reserve for maintaining stable financial position
- Enables the RIPE NCC to operate soundly and continuously





# RIPE NCC Surplus 2019



- The Board is proposing adding the 2019 financial surplus to the RIPE NCC capital reserves
  - Option A proposes adding the entire surplus to the reserves
  - Option B proposes adding 50% of the surplus to the reserves and redistributing the other half to members
- The surplus has a strong link to the one-time sign-up fees paid by members
- Members can vote on the redistribution at this GM
- If members vote against both options of the resolution, the surplus will be redistributed to the membership in 2020

# Joint Meeting with APNIC



- Held in Chiang Mai, Thailand jointly with the Executive Council of APNIC
- Inter-RIR meetings are held regularly
- The last joint Meeting with APNIC was in 2016 in Copenhagen
- Aimed at ensuring the stability of the global RIR system
- High-level strategic and inter-RIR cooperation
- Allows us to share resources, build on each others' work
- Joint projects with APNIC include RIPEstat, RPKI, DNS (Root and Reverse DNS) among others

# Ongoing Work



- Supervising the strategic direction of the RIPE NCC
- Finalising the Activity Plan and Budget 2020
- Engaging with the community and members
- Work with the RIPE NCC management
- Cooperation with other RIR boards

# Management Changes



- Axel will step down as Managing Director
- Felipe (COO), Gwen (CFO) and Kaveh (CIO) will become the Management Team for an interim period
- This will ensure continuity of services and stability
- We will quickly start the search for a new Managing Director
- The Board thanks Axel for everything he has done to support the membership, the Board and the RIPE NCC staff
