

RIPE NCC Test Traffic Measurement Service

The RIPE NCC offers the Test Traffic Measurement (TTM) Service for the purpose of collecting data describing the performance of the network between providers, such as network delays, packet losses or routing information, and to present the collected information in a formt useful to the customer.

To achieve this, measurement probes are installed at the sites interested in this service. We call these probes "test-boxes". The RIPE NCC will provide one or more test-boxes to the customer, as defined below. The RIPE NCC will operate the test-boxes for the customer as "black boxes".

The customer wishes to obtain a test-box and to receive the TTM service, and subject to the provisions below and the General Terms and Conditions, the RIPE NCC hereby undertakes to provide the service to the customer as defined in the current version of the TTM Service document.

This contract describes the Terms and Conditions for the purchase of a test-box and for the subsequent operation of it by the RIPE NCC.
