# Registration Services

- Documentation update
  - Improving clarity of English for supporting notes on all request forms
- Request handling
  - Request numbers: steady
  - Service level: stable
- Organisation
  - Staff functions updated to reflect responsibilities and skills
  - Requests handled by IP Resource Analysts

  - New LIR course
  - Updated RR and DNSSEC

# Training in 2005

- 62 courses planned for 2005
  - 40 LIR, 13 RR, 9 DNSSEC
  - Capacity for 1440 participants
- Upcoming Q2 (May June)
  - LIR: Amsterdam, London, Prague, Munich, Poznan, Sochi
  - RR: London, Paris
  - DNSSEC: Brussels
- Q3 (July September)
  - LIR: Vladivostok, Amsterdam, Copenhagen, London, Stockholm, Berlin,
    Dubrovnik, Budapest, Madrid, Moscow
  - RR: Vladivostok, London, Sofia, Vilnius
  - DNSSEC: London, Moscow
- Q4 (October December)
  - Paris, Yerevan, Kiev, Rome, Dubai, Lisbon, Athens, Nuremberg, Tirana



#### **Back-Office Focus 2005**

- Resource management system
  - "Evolution" since 1992
  - Needs serious streamlining
    - i.e. throw out, replace, integrate
- Integration of "ticketing islands"
  - Replacement of current system(s) (!)
- Pre-historic PABX to be replaced
  - Keep up with technology and jump ahead...
- In short:
  Our engineers are really busy internally this year...



# Engineering internals

- DNSMON / TTM transition to Ops group
- Improved centralised backup
- DNS infrastructure evolution
  - Improving zone distribution and checks
  - Functional split across servers for all zones
  - Migration of zones onto appropriate nameservers
  - In preparation for DNSSEC deployment.
- Hosting of computing facilities for NRO / ASO secretariat
  - Efficient secretariat transition



#### k rootserver

- 14 mirror instances deployed.
  - 3 more being installed
- 2 globally visible, 9 locally visible
- Since RIPE49:
  - RIX Reykjavik, BIX Budapest, FICIX Helsinki, CIXP Geneva,
    PCSS Poznan, JPNAP and DIX-IE Tokyo, EMIX AbuDhabi.
- Initial goal (deploying several "local" instances) is achieved.
- Research improvement of service
- After analysis possibly another phase of deployment



#### Whois Database

- Whois Database Changes
  - Whois server migrated from single Solaris machine to Linux cluster.
  - Average query response time back down to less than 0.1 second
  - Updates much faster, on dedicated server
- New or changed functionality
  - RPSLng (IPv6 and multicast support for routing registry)
  - Abuse changes (improved ability to report and find abuse contacts)
  - POEM object (new, general LIMERICK object)
- Public CVS with source code now available



#### RIS

- RIS (Routing Information System)
  - RIS query CGI's rewritten; now support IPv6
- Beacon prefixes modified
  - request from RIPE 49



## **New Developments**

- DNSMON now regular service for TLD administrators
  - Costs of operating the service are being paid by the TLD administrators as requested by membership
  - Service agreement ripe-342, subscribers 7+3+2
  - Testbox hosts receive DNSMON as part of the TTM package
- Hostcount++ revision proposal
- DNSsec: design team working on deployment in in-addr-tree
- Anycast research ongoing
- AS-MIA paper presented, ongoing effort
- TTM
  - Improved timestamping, OWAMP implementation (ongoing work)



# Coordination / ERX Project

- Transfer Early Registrations from ARIN to registrant's local RIR
  - AS Numbers, former 'Class B' space, former 'Class C' space
- Aug 2002 Mar 2005
- Achievements
  - Developed distributed DNS management system
  - Introduced web response system
- Problems
  - E-mail notifications for 192/8
  - Solved and closed
- AfriNIC
  - About 80 records to be transferred to AfriNIC this summer

  - Middle East, early November 2005




# Signing of new Standard Service Agreements
