#### What is RIPE?

• RIPE = Réseaux IP Européens

 Community of people interested in IP networks and how they are managed and governed

Started in 1989 by network operators in Europe

• Coordinate, collaborate, share information & knowledge



#### RIPE - Multi-stakeholder Model

- Develops policies around Internet number resources
  - IP addresses and Autonomous Systems
- Policy Development Process is based on consensus

- Open to anyone
  - You can get involved via meetings and mailing lists

#### **RIPE Community**



- Formed in 1989
- Open to all!
- Information exchange
- Technical coordination
- Policy development
  - Based on consensus

#### RIPE NCC



- Formed in 1992
- Membership organisation
- Provides services to members and community
- Implements policies developed by RIPE



# RIPE Structure and Decision Making

- RIPE Community level
  - RIPE Plenary sessions
  - Open mailing lists
- Expertise/topic level
  - 12 active WGs at the moment
  - Examples: Cooperation, Address Policy, Internet of Things
- Open RIPE documents to archive decisions, practices, policies
- Collaboration with other stakeholders and communities



# What Happened Since Last Year?

- First formal RIPE Chair selection process
  - Established by the RIPE Community
- Two virtual RIPE meetings in 2020
  - Increased attendance, good engagement
- Active Task Forces
  - Code of Conduct (next version)
  - RIPE Database Requirements
- Following accountability recommendations



## RIPE Accountability Task Force

- Purpose: good governance and transparency
- Report was published in 2019
  - 15 recommendations
  - Several have been done
  - Community is actively working on the others
