## Challenges

### Concerns about the quality of registration data

- Outdated contact details
- Companies moving and merging
- Falsified contact details

### IP address hijacking

- Outdated or poorly secured registration information
- Risks from inside resource the holder's own organisation
- Threats to the stability and resilience of the Internet

# **RIPE NCC Due Diligence**

- Strict Standard Service Agreement (SSA), allows membership closure for:
  - Incorrect data or unresponsiveness
  - Policy violation or provision of fraudulent information
- Investigations with internal and external experts
- Constant adjustment of processes





### Developed bottom-up



### "Regular abuse-c Validation"

- Policy approved in June 2018
- Gives the RIPE NCC a mandate to regularly validate "abuse-mailbox:" information and to follow up in cases where the attribute is deemed to be incorrect
- Automated check + manual check = accuracy

## "Publication of Legal Address" Proposal

- Needed to:
  - Combat malicious actors
  - Facilitate legal processes
- Lively discussion with both support and objections proposal will be re-written, with the new version expected in Q1 2019.



• RIPE NCC to publish the validated legal address of the organisation that holds an Internet number resource
