# **RIPE NCC**



In recent years, the RIPE NCC has developed its capacity to engage strategically with governments, law enforcement agencies (LEAs) and intergovernmental organisations on behalf of its membership and community.

The External Relations Department now have staff in Amsterdam, Dubai and Moscow and we are now working to use those resources to the greatest benefit for all RIPE NCC stakeholders.

#### **RIPE NCC**



- The RIPE NCC's liaison strategies in this area include:
  - RIPE NCC Roundtable Meetings for Governments and Regulators in various regions
  - Engagement with LEA representatives through our own dedicated events, direct capacity-building efforts with specific agencies and participation in LEA events
  - RIPE NCC now have staff who have experience in working in the LEA and government arena to boost our efforts in dealing with LEA and governmental stakeholders

# **RIPE NCC - what are we doing**



- Direct engagement with government agencies on issues relevant to the RIPE NCC, its membership and the RIPE community across our entire service region
- Participation in international discussions of Internetrelated public policy development in forums including the IGF, EuroDIG, ITU and many more
- Cooperative educational and capacity building initiatives with public sector organisations and industry partners
- We have held and participated in over 80 events in 2015

- Training courses (Interpol Staff and Member states) on the RIPE Database

# **Europol - EC3**



- Joint Cyber Action Taskforce (J-Cat) RIPE NCC staff have been involved in an advisory role, training and capacity building
- Training courses for EC3 staff and member states
- Communication Providers Advisory Groups we have applied and are encouraging others in the community to apply

- Working with DG HOME and DG CNECT on how we can be used to as centre of excellence in discussions around IoT, smart cities, security and trustfulness on the Internet
- Training/Awareness/Capacity building

# **RIPE NCC and CSIRTs**



- RIPE NCC official CSIRT established
- Members of CSIRT Task Force
  - Regularly attending and present at their meetings
- Working with CSIRTs on RIPE document
  - List of various data sets useful for abuse handlers
  - Working on common interface to automatically access these data sets

# **RIPE NCC Website**



- Better communication
- Better cooperation of LEAs on the content
- RIPE Database not a 'whois'
- Training courses, both online and offline
- Training in local language where possible
- Making it more LEA/government friendly
  - Less "geek talk"

- AA-WG Anti-Abuse Working Group
  - Discusses topics relating to Internet abuse and ways to prevent it
- Coop-WG Cooperation Working Group.
  - Primarily discusses outreach from the traditional RIPE community, especially governments, regulators and NGOs, all of whom we would like to see engage more with our community
