Whereas:

1. The Requesting Party has entered into either a Standard Service Agreement with the RIPE NCC or an End User Assignment Agreement with a sponsoring LIR (both agreements or either agreement hereafter referred to as "Basic Agreement").

2. The Requesting Party requests the RIPE NCC to prevent the resources listed below, as assigned/allocated by the RIPE NCC to the Requesting Party (hereafter referred to as "Internet Number Resources"), from being transferred for a duration as specified below (hereafter referred to as the "Lock") in accordance with the RIPE policy "<u>Voluntary Transfer Lock"</u>.

The Requesting Party:

1. Requests that the RIPE NCC undertake the appropriate actions to implement the Lock for the following Internet Number Resources:

3.3 The Requesting Party cannot request the revocation of the Lock once it has been implemented.

3.4 The Lock will expire at the end of the Lock duration as indicated above. To continue with the Lock after the expiration of the Lock duration, the Requesting Party will have to submit a new request to the RIPE NCC.

3.5 Any other rights and obligations that arise from the Basic Agreement, including any other rights to any other Internet number resources registered to the Requesting Party by the RIPE NCC, are not affected by the Lock.

3.6 In the event that a provision in a separate agreement is in conflict with a provision in this Voluntary Transfer Lock Request Form or the Basic Agreement, the provision in this Voluntary Transfer Lock Request Form and the Basic Agreement shall prevail.

3.7 The RIPE NCC shall not be responsible and cannot be held liable for the implementation or non-implementation or non-enforcement of the Lock due to any reasons, including restrictions from RIPE Policies, RIPE NCC procedural documents or the applicable law, or any disputes between the Requesting Party and any (third) parties.

3.8 If any of the information and/or documentation provided in connection with the Lock is subsequently found by the RIPE NCC to be substantially incorrect, falsified or misleading, the RIPE NCC reserves the right to cancel the Lock before the Lock duration has expired. This applies to all information and documentation provided to the RIPE NCC by the Requesting Party with regards to the Lock.

3.9 The RIPE NCC shall not be responsible and cannot be held liable for any direct and/or indirect damages, including damages to Requesting Parties' business, loss of profit damages to third parties caused due to the implementation or non-implementation of the Lock or the ongoing maintenance of the relevant records in accordance with the Lock.

3.10 The Requesting Party shall indemnify the RIPE NCC against any and all third-party claims filed against the RIPE NCC in relation to the Lock.

3.11 The RIPE NCC reserves the right not to enforce the Lock, even if the Lock request has been approved by the RIPE NCC. The RIPE NCC may not enforce the Lock, for example, in

case of Transfers of Internet Number Resources Due to a Change in the Requesting Parties' Business Structure or Transfers Due to Seizure.
