Getting an IPv6 allocation from the RIPE NCC

- To qualify, an organisation must:
 - Be an LIR
 - Have a plan for making assignments within two years

Minimum allocation size /32

 Allocation size is based on customer numbers and growth, not on transition technique!




RIPE Policy Proposal 2011-04

- Extension of the Minimum Size for IPv6 Initial Allocation
 - Proposes initial allocation up to a /29
 - For example, for small LIRs to deploy IPv6 via 6RD (RFC 5969)


- Proposal accepted 2 May 2012
- The RIPE NCC is working on the implementation



IPv6 Allocations per month




IPv6 Allocations per month CZ




IPv6 Deployment: RIPEness

- Rating system:
 - One star if the LIR has an IPv6 allocation
- Additional stars if:
 - A route6 object is in the RIPE Database
 - Reverse DNS is set up
 - IPv6 Prefix is announced
