# RIPE NCC Roundtable Meetings

- Target group: Government, LEAs, Regulators
- 6 Roundtable Meetings since 2005
- Last Meeting Sept 2008
  - Government + invited RIPE Community Members
  - Topics: IP address registration, IPv4 exhaustion / IPv6 deployment, IP policies overview, criminal activity on the Internet
  - 26 Government representatives from 11 countries
- Future meetings
  - 2 meetings per year (16-17 February / September)

IPv6 deployment cases - both from industry & Government

## Day 2:

- Session dedicated to LEAs
  - Dutch Ministry of Justice to lead discussions
  - Closed meeting to develop a closer working relationship & discuss needs for global coordination
  - Define where we can make the process of requests easier and faster

- RIPE Cooperation Working Group

- Working Group charter established
- Focus on cooperation between the private and public sectors on Internet matters
- Develop and clarify the RIPE community's position on issues raised by public sector
- Discuss and propose policies
- Forum to help solve problems

- Workshops for governments in the RIPE NCC service region - organised by local governments
- Training courses tailored for governments & LEAs
  - EU commission, Dutch Police, OPTA
  - More planned for 2009



#### **Governance Partners**

- Work together to provide information the big picture
- Approach governments, LEAs, regulators with governance partners (RIRs, ICANN, IANA, ISOC)
  - Gulf Cooperation Council
  - OECD
- Working with governance partners to participate in local IGFs
  - DE, UK, RU



#### What Have We Learned?

- Different working environments have had to adjust
  - RIPE process is inclusive but another forum was needed for more open dialogue with government, LEAs, regulators
- Governments seek a position on Internet issues and want to participate
  - We are finding ways to make this happen
- Law Enforcement & Industry need to work closer in order to make a difference



# **Next Steps**

- Continue to expand relations with local government in RIPE NCC service region
  - Target information releases / consultations
- Lead public/private sector dialogue in various government initiatives
- Coordinate positions of RIPE community for input to government (Cooperation-WG)
- Implement processes developed jointly to meet the needs of stakeholders

- Identify key staff as contacts for government, LEAs, regulators
  - Channels to information quickly
- Work with RIR colleagues to share information and experiences to be more effective for stakeholders
