



Policy Update (1)

- Policy Development Process
 - Updated draft PDP to be published
 - Improved tracking of current proposals
- TLD Anycast Allocation Policy
 - Revised formal proposal posted for discussion
- IPv6 allocations to LIRs
 - Proposal to remove 200 /48s criteria published
- HD-ratio for IPv4
 - Proposal published





Policy Update (2)

- Whois review
 - Review document being published based on discussion during RIPE49
- Policy for African LIRs
 - Proposal to remove this policy published



Training

- Training Activities focusing on major RIPE NCC activities
 - New LIR course material to be launched during RIPE 50.
 - "Using RIPE Whois DB" to be launched after RIPE 50
- Preparing CBT delivery
 - Working closely with APNIC



k root

- K rootserver anycast
 - Abu Dhabi deployed
 - Tokyo up and running
 - Third "global" node
 - Dubai and Novosibirsk being switched on
 - http://k.root-servers.org/



Whois / RIS

- Whois Database Changes
 - Whois server migrated from single Solaris machine to Linux cluster.
 - Average query response time back down to less than 0.1 second
 - Updates much faster, on dedicated server
- New or changed functionality
 - RPSLng (IPv6 and multicast support for routing registry)
 - Abuse changes (improved ability to report and find abuse contacts)
 - POEM object (new, general LIMERICK object)
- Public CVS with source code now available
- RIS (Routing Information System)
 - RIS query CGI's rewritten; now support IPv6



Back-Office Focus 2005

- Resource management system
 - "Evolution" since 1992
 - Needs serious streamlining
 - i.e. throw out, replace, integrate
- Integration of "ticketing islands"
 - Replacement of current system(s) (!)
- Pre-historic PABX to be replaced
 - Keep up with technology and jump ahead...
- In short:
 Our engineers are somewhat busy internally this year...
