Dear Mr. Petter Holen,

I trust this letter finds you well. I am writing to bring to your attention the incorrect designation of Taiwan on your website.

Recently we have received complaints from our compatriot concerning the incorrect designation refer to "Taiwan" as "Taiwan, province of China" in the "list of Members" page on your website (as attached).

This erroneous designation creates the impression that Taiwan is part of the People's Republic of China, which is completely contrary to reality and constitutes a misjudgment of the legal and international status of Taiwan. In reality, the People's Republic of China has never exercised any jurisdiction over Taiwan. In terms of its legal and international status, Taiwan is a fully-fledged democracy with its own elected President, Parliament and independent judiciary, based on its own Constitution. Taiwan independently conducts its own foreign affairs and defense policy, issuing our own passport and currency, and the country is widely regarded by the international community, both in reality and virtual world, a trustworthy partner and contributor.

We acknowledge that the website's content adheres to the standards outlined in ISO 3166. However, we suggest that alternative approaches could have been considered to prevent potential misunderstandings prior to the correction of the ISO system. For instance, enclosed please find the usage of Asia-Pacific Network Information Centre (APNIC) and American Registry for Internet Numbers (ARIN), which referring to

Taiwan as "TW" under the section of "Economy," or using A2/A3 codes from the ISO system to categorize members in the "Country/Geographical Areas" section.

In addition to that, enclosed please also find the usage of the Government of the Netherlands Website (Ministry of Foreign Affairs), which referring to Taiwan only as "Taiwan," for your reference. I encourage you to follow the above-mentioned practices.

It would be highly appreciated if you could help adjust the improper and misleading designation as soon as possible. My colleague Mr. Jonathan Yang (email: tyyang@mofa.gov.tw; tele: 06-20400489) remains at your disposal for further questions on this matter.


