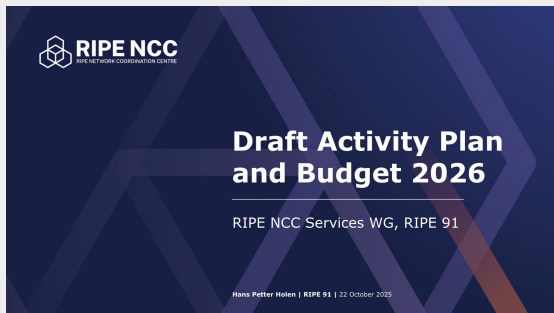

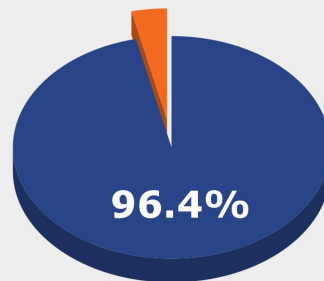

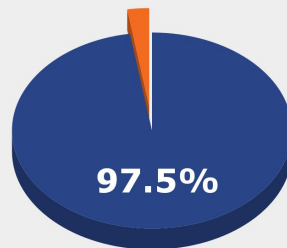
- High level of ARCs completed, annual target: 2,400 (1,820 realised year to date, 1,600 forecasted)

We have also initiated several projects which will continue throughout 2025:

- **'Stop sponsorship' workflow**
 - This workflow has been automated to stop an end-of-year run on tickets
 - Marco Schmidt will showcase this in the Address Policy Working Group session at 11:00 on Thursday
- **Moving ARC to Self-Service**
 - We're laying the groundwork to validate all members every two years (instead of five)
 - Share your feedback on the current process with our User Research Team at RIPE 91
 - Your input will help shape the next phase of our ARC automation tools
- **Continuous monitoring of End Users**
 - We're already matching records through automated systems
 - By mid-Q4 we expect to automatically track end-user changes
 - This will help us keep our data accurate and up-to-date

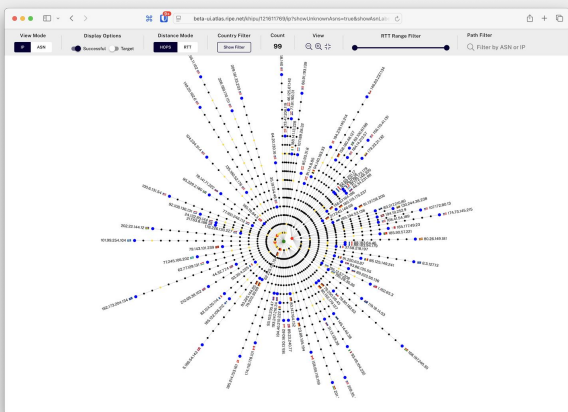

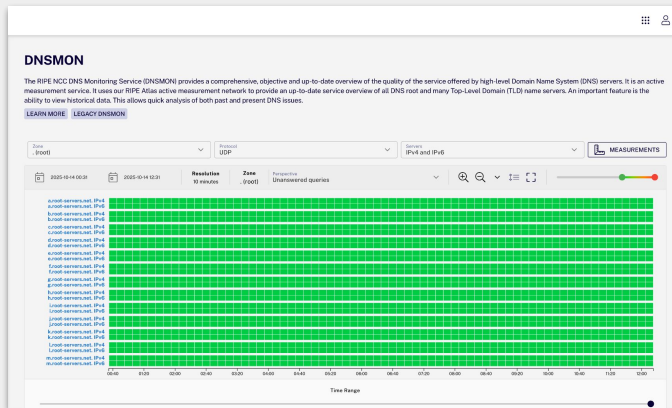


New traceroute visualisation tool



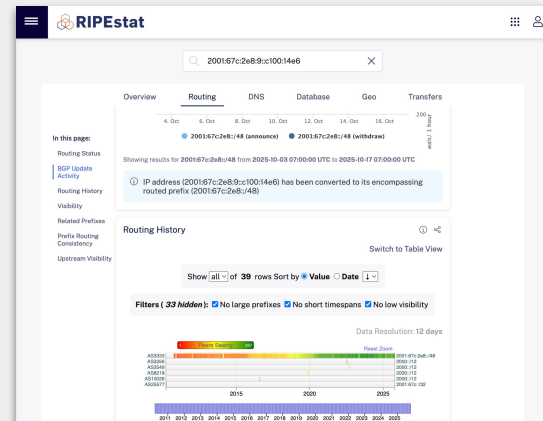

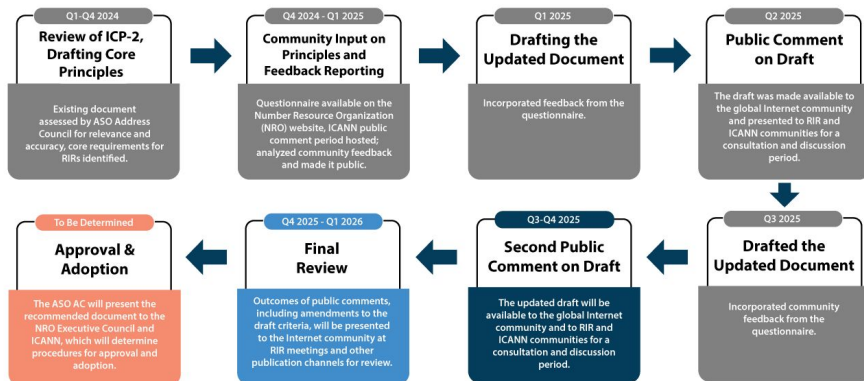

The ICP-2 Review Process Explained

In 2023, the ASO Address Council began reviewing Internet Coordination Policy 2 (ICP-2), which was developed in 2001 to set criteria for the establishment of new Regional Internet Registries. The review is needed to ensure the criteria remains relevant, accurate, and aligned with today's Internet landscape. Review of ICP-2 is an open and transparent consultation process, allowing participation from across the global Internet community.

The RIPE NCC Signs New MoU to Renew Commitment with APTLD

The RIPE NCC and the Asia Pacific Top Level Domain Association (APTLD) have signed a new Memorandum of Understanding (MoU) renewing their commitment to cooperate on the promotion of Internet coordination activities.

The MoU was signed by Hans Petter Hølen, RIPE NCC Managing Director and CEO, and Ai-chin Lu, Board Chair of the Asia Pacific Top Level Domain Association, during APTLD 88 in Belgrade. Afterwards, Hans Petter presented an update from the RIPE NCC, followed by presentations from representatives of other organisations.



With this MoU, both parties reaffirm their intention to exchange information, participate in projects and building, and advocacy for the technical community.

UNDP and RIPE NCC Sign MoU to Strengthen Digital Cooperation for Sustainable Development

New York, 25 September 2025 – The United Nations Development Programme (UNDP) and the Réseaux IP Européens Network Coordination Centre (RIPE NCC) today signed a Memorandum of Understanding (MoU) at UNDP Headquarters in New York alongside the UN General Assembly High-Level Week.

The agreement establishes a new framework for collaboration to enhance scalable, secure, and resilient Internet infrastructure and digital ecosystems across the Arab States and beyond. It brings together UNDP's development mandate with RIPE NCC's technical expertise as a Regional Internet Registry to promote inclusive digital transformation, support digital public infrastructure, and accelerate progress toward the Sustainable Development Goals (SDGs).



TRC Jordan and RIPE NCC Sign MoU at WSIS+20

Geneva, 9 July 2025 – At the WSIS+20 High-Level Forum, which took place from 7 to 11 July in Geneva, the Telecommunications Regulatory Commission (TRC) of Jordan and the RIPE NCC signed a Memorandum of Understanding (MoU). This formalised a strategic partnership aimed at enhancing Internet infrastructure, capacity building, and digital resilience in Jordan and throughout the region.

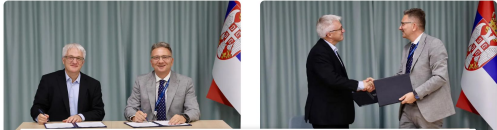

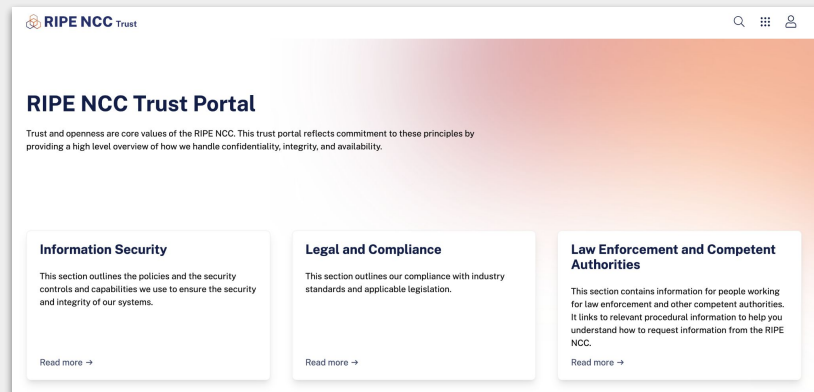

Redesigned RIPE Fellowship programme: Updated structured learning approach and introduction of a '101' course and quiz before people can apply

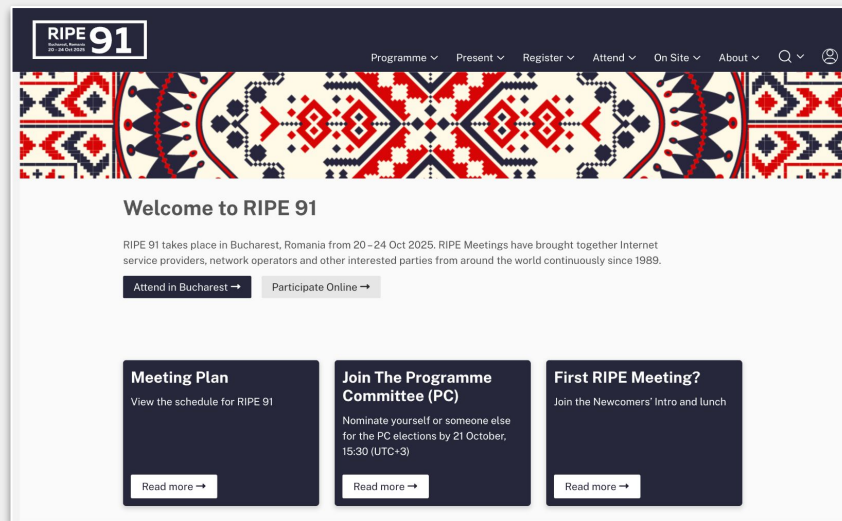
New RIPE Meeting websites: Replatformed to make them more accessible, allowing for easier maintenance and updates, and integrated with Pretalx
