








- 2,910 eligible voters

- 86 countries


## Registered Vote per Country

#### Voting Platform - What's New?



- New UI from Assembly Voting
- Opening and closing ceremonies are now completed with a key transferred to a RIPE NCC server
- Members need to be TLS 1.2 compliant in order to receive emails from Assembly Voting
- Please note: If you drop off, you will have to start again

## New Voting System - Ceremonies



- Opening and closing keys ceremonies:
  - An election can only be opened after an opening ceremony with encrypted keys
  - Assembly Voting and the RIPE NCC now store the key on servers
  - Only once these keys have been entered into the system together can an election begin
  - Once the keys ceremony has taken place, all subsequent actions by all parties can be seen on the Bulletin Board
  - This process is duplicated for a closing ceremony where the voting report is produced once all parties have entered their keys

## Split Voting and Instant Run-Off



- Assembly Voting now meets our requirements with a new system implemented in early 2023
- People representing more than one member can now vote once rather than having to complete individual votes
- Assembly Voting have also implemented our instant run-off voting calculations - the first of its kind that they've seen

#### How to Vote




Voting can take place once the Chair declares voting open

#### **Electronic Voting**

- Electronic voting is available to all members who have registered to vote electronically
- Electronic votes can be cast until 09:00 (UTC+2) on Friday, 26 May 2023
- There are NO paper ballots at this GM





You will receive TWO emails

One will include your pass code needed to log in to the election platform. This will come from the RIPE NCC.


Your personal Assembly Voting ID ( is transferred in the link and you only need to type in your RIPE NCC Password.

The system can be accessed on your preferred device with access to a browser. Please be aware that Internet Explorer cannot be used to access the system.

In another email, you will receive a link to the election platform which also includes your election code. This one will be from Assembly Voting.

Click the 'Vote Now' button or link in the email to start voting.





The election code is autopopulated.





#### Voting on Resolutions



- There are six Resolutions to be voted on:
- Resolution 1 requires more than 50% YES votes to pass
- Resolution 2 requires more than 50% YES votes to pass
- Resolution 3 uses instant run-off
- Resolution 4 requires more than 50% YES votes to pass
- Resolution 5 requires more than 50% YES votes to pass
- Resolution 6 requires more than 50% YES votes to pass
- The RIPE NCC Executive Board Elections uses instant run-off

Note: Abstentions are noted, but do not count!
