


19,295 eligible voters • 1,577 votes registered - The voter turnout is 8.2%

## Voting on Resolutions

- There is one Resolution to be voted on with three options
- Instant run-off voting is used for this Resolution
- Ranking options:
  - You must fill at least one preference for a ballot to be considered valid (or choose to abstain)
  - preference
  - You can choose to fill as many preferences as there are options

Important: Abstentions are noted, but do not count!

- You must number the options of the Resolution in order of preference with 1 being your top

## Instant Run-off Voting (IRV)

- Instant Run-off Voting is a preferential voting system where to win
- If no option receives more than 50% in a round of voting, the option with the fewest top preference votes is eliminated
- The system then recalculates after redistributing votes according to the order of preference
- This process of elimination and recalculation continues until an option receives more than 50% of top preference votes

## How IRV Applies Here

- There are three options in the resolution: A, B and C
- When the votes are counted, if none of these options has more than 50% of first preference votes, then:
- One of the options is eliminated
- The second preferences for the eliminated option are redistributed to the other two options
- The option with the most votes at this stage is the one approved by the GM

- Electronic voting is available to all members who have registered to vote
- Electronic votes can be cast until 09:00 (UTC+1) on Friday, 26 November 2021
- We use a third-party system BigPulse for voting
