# **Registration Overview**

  - that's a record!







# Voting at the GM



- Two ways to vote at the GM:
  - Paper ballot (attendees only)
  - Electronically (remote participants and attendees)
- Voting starts at Agenda point 9
- Paper ballots MUST be handed in before you leave the room
- Electronic votes can be cast until 09:00 UTC+2 on Friday, 18 May

### The Resolutions



- Each resolution needs more than 50% of YES votes to be approved
- Abstentions are noted but do not affect the count
- Electronic voters received a link to the voting application today

Turn over for resolutions 6 - 9

- Make a mark in one box only for each resolution or your vote will be deemed invalid
- There are resolutions on **both sides** of the paper ballot

### **Election**



- Six candidates in the Executive Board election
- Instant run-off voting is used for the election
- You need to rank the candidates in order of preference from 1 (your most preferred) to 6 (your least preferred)
- You can select just 1 if you want (or 2 or 3)

#### **Election**



- Candidates need over 50% of votes to be elected
- If no candidate reaches 50% of the votes in the first count, the candidate with the fewest votes is eliminated and the remaining vote counts are recalculated
  - And so on until someone receives 50% of the votes

### **Election**



- After this process, the winner of the first seat is removed and the calculation is redone for the second seat
- You should fill preferences 1-6 to be sure your vote always counts

After the resolutions, you will be presented with the Executive Board election. You will need to number your candidates from 1 to 6 in order of preference. You do this by clicking the boxes beside each candidate's name.

The weighting displayed in the voting software reflects the number of members you are authorised to vote for.

# Counting the Votes



- We use the third party BigPulse system for voting
- The paper ballots are stored in the hotel safe until 09:00 UTC+2 on Friday
- After the voting deadline passes, paper votes are added to the electronic votes in the BigPulse system
- Independent observers from the other RIRs oversee the input of paper ballots into the system
