# **December 2016 Meeting**



- Approved the Activity Plan and Budget 2017
- Instructed the RIPE NCC Management to redistribute the surplus amount to the members
- Decided that new membership applications from legal entities that are related to each other should be processed one at a time
- Approved the updated RIPE NCC Treasury Statute

# March 2017 Meeting



- Agreed to submit the Financial Report 2016 for the GM (to be voted on today)
- Approved the RIPE NCC Charging Scheme 2018 to be presented to the members (to be voted on today)
- Instructed the RIPE NCC to report any cases of fraud to the relevant authorities
- Decided that the RIPE NCC will not join the SEED Alliance at this time but will revisit our participation in the future

# **Charging Scheme Discussion**



- In September 2016, we opened discussion on the RIPE NCC charging scheme model
- Several different models were suggested by members across the service region - there was no clear guidance
- Other members expressed support for the current model - one LIR-one fee
- The Board decided to retain the current model for the 2018 proposed charging scheme

#### Outreach



- From 2018, the RIPE NCC plans to support one regionally-focused meeting per year in the ENOG, MENOG and SEE regions
- The RIPE NCC will increase efforts in hosting national and local meetings, Member Lunches, training courses and other tailored events focusing on specific issues of interest
- This will take place in communities throughout our service region

- Liaising with other RIR boards
- Supervising the RIPE NCC management
