- Board has no influence on the policies of the RIPE community



Board Decisions – November 2012

- Re-instated ASused tool
- Check member list vs "sanctioned list" once a year
- Waived sign-up and annual service fee for Legacy Resource holders in 2013
- Approved Activity Plan and Budget 2013



Board Decisions - March 2013

- Approved Phase 1 of Resiliency Plan for services
- Not appealing court verdict re: "Policy Order" challenge
- Decided not to release RPKI service for PI End Users prior to Community policy action
- Continued free RIPE DB Proxy Service under contract
- Approval of "Draft Charging Scheme 2014"
- Approval of Draft Financial and Annual Report 2012
