 - the written support of at least five Members

Proposed amendment from EB Elections Task Force

- a certified copy of an official identification document
- a signed statement that declares
- adherence to the CoC for Candidates, and
- that he/she never committed fraud or other financial misconduct in any jurisdiction

 Requirements or restrictions relating to RIPE NCC Executive Board positions could be developed and applied

- Limit the number of Executive Board members that have employment relationships with the same company or organisation

- Limit the number of Executive Board members that (partially) own the same company

- Limit the number of Executive Board members that have have the nationality of the

- Executive Board members may not be in the board of another Regional Internet Registry (RIR), ICANN or the Internet Society

- Executive Board members may not be chairs of RIPE community working groups or members of the NRO Number Council
