- Issue with ruling
 - No flexibility to change the charging model i.e. changes not allowed or re-discuss
 - No guarantee ruling will be continued or will apply towards the future or even retrospectively

- All other contract holders become members
- Services available for all members
- Additional categories for XXS and XXL members
- No charge for Legacy Resources
- No charge for IPv6 no category shift
- Decrease in sign-up fee
