## **Registry Update**

- Sharp increase in the number of transfers in the last year Extra work from EU sanction compliance
- We have increased staff levels for Registry Services
- Looking at ways to improve efficiency and response times
- Long-term solution involves automation and digitisation of the Registry
- Continue to automate member checks against EU sanctions list to improve wait times





## AuthDNS and K-root

- Core nodes: locations we fully maintain and are responsible for
- Hosted nodes: community members provide equipment and connectivity, we maintain them remotely
- K-root hosted node model has been running for a number of years, with around 80 hosted nodes currently
- After a successful pilot, operators can now also host AuthDNS nodes in their own networks
- Host a K-root node, AuthDNS node or both: https://hosted-dns.ripe.net/

## The Community Projects Fund

- Over 30 projects have been funded for the 'good of the Internet'
- Funding of EUR 250,000 to support projects of value to the operation, resilience and sustainability of the Internet
- Call for applications this year opened in June
- 20 applications were received from 16 countries
- Nine projects have been selected for 2021 funding
- Projects awarded from EUR 10k to EUR 50k

### Стать членом RIPE NCC

Члены RIPE NCC могут подавать заявки на выделение адресов IPv6 и номеров AS и предоставлять ресурсы [assignments] пользователям [End Users] или клиентам.

У нас закончились адреса IPv4, но соответствующие критериям члены могут запрашивать выделение [allocation] в размере одного блока /24 согласно очереди IPv4.

Участники также получают доступ к широкому спектру услуг, таких как учебные курсы, сертификация ресурсов [resource certification] (RPKI) и инструменты Интернет-аналитики. RIPE NCC также организует онлайн и оффлайн мероприятия, в рамках которых сообщество может обсуждать насущные вопросы.

### Sanctions Update

- We are subject to EU sanctions regulations
  - Cannot make further Internet number resources available to sanctioned entities
  - Any resources that have already been registered to sanctioned entities must be frozen in the RIPE Database
  - We do not have to deregister resources in these cases
- Improved and automated our monitoring of membership information against EU sanctions
- First quarterly sanctions transparency report published:

- Talks with our banks are ongoing they have their own compliance obligations
  - Invoices for 67 members in Iran and Syria continue to be postponed
