The RIPEstat interface has been completely rebuilt, modernising the original 2013 design with a fresh look and improved user experience.

We have reworked the probe detail pages to make them cleaner, more user-friendly, and enriched with new features.

## RPKI Enhancements

We are working on implementing support for ASPA in the RPKI UI.



## RIPE Database

To improve security, we have phased out MD5-hashed passwords. We have introduced API keys linked to RIPE NCC Access accounts.

## LIR Portal

We have implemented a new OAuth 2.0-based authentication solution.

We will also introduce automated monitoring of End Users and an automated option to stop the sponsorship of End Users.

We have launched a Trust Portal that provides an overview of our information security and risk mitigation efforts.

## Compliance Frameworks and Audits

Organisation-wide, we are working on establishing compliance with the ISO 27001 framework.

An ISAE 3000/SOC 2 Type 2 audit is in progress for our RPKI service, and we will implement the findings of the audit in Q4 of this year.



We offer online learning through our webinars and the RIPE NCC Academy, as well as in-person training courses and certification through RIPE NCC Certified Professionals exams.

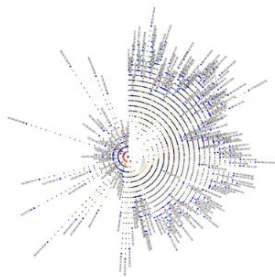

## Khipu: Prototype RIPE Atlas Traceroute Visualisation Tool

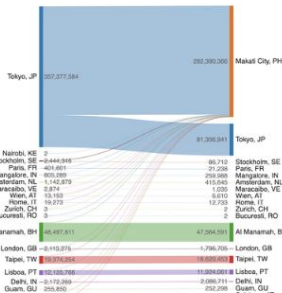

# New RIPE Fellowship Program

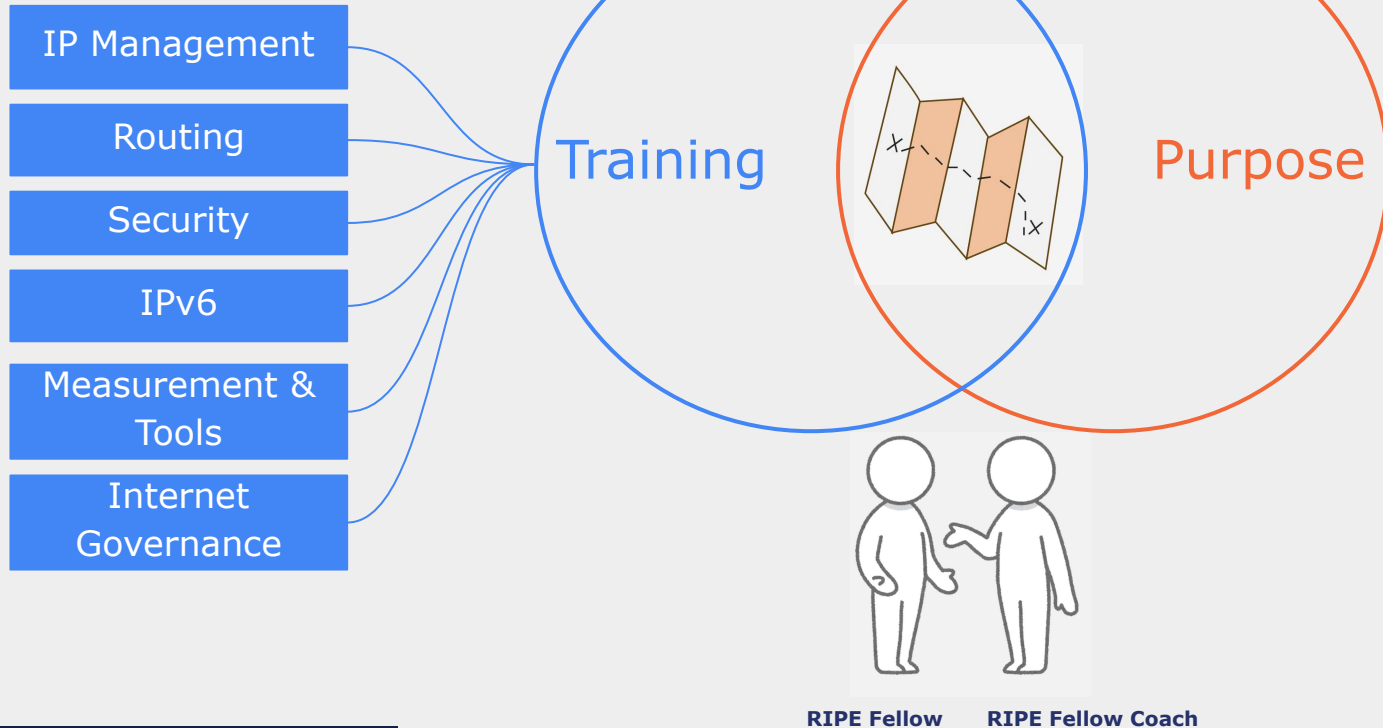


- The New RIPE Fellowship connects **Fellow's personal interests** with **specific areas of interest** of the **RIPE community**

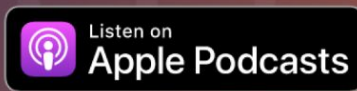
